<b>1. Justification</b> The approval of this section of SH 3 in conjunction with the approval of US 12 requested in a previous form, would connect Kendrick, ID and Bovill, ID with the rest of the 129,000 pound designated route network via US 95. SH 13 is an essential route connecting US 95 and US 12 and thus Western Idaho with Western Montana.		
<b>2. Associated Economic Benefits</b> The approval of both of these stretches of highway will allow Doug Andrus Distributing to better serve the Idaho Transportation Department in delivering road salt to different maintenance sheds. Increasing weights from 105,500 to 129,000 will be a massive boost to the efficiency of road salt transportation, allowing Doug Andrus and other competitors to help ITD lower the cost of transportation in the future. The approval of both of these routes would round out the 129,000 designated route network in Western and Northern Idaho and allow business owners and farmers to ship commodities and goods in a much more efficient manner. Less trips per truck also means better wear, increased life, and less maintenance on Idaho's highways.
