General Message from the Highway Safety Manager

Hi Highway Safety Partners:

A <u>report</u> released by the Governors Highway Safety Association (GHSA) highlights the continued role <u>speeding</u> plays in traffic deaths and makes recommendations to address the problem. Despite progress in nearly every other area of highway safety, speeding continues to be a factor in approximately one third of traffic deaths every year across the nation and here in Idaho. Nationwide since 2000, the share of traffic fatalities linked to speeding has increased by seven percent, even as seat belt non-use in fatal crashes dropped 23 percent and alcohol-impaired fatalities declined three percent. Speed remains the one highway safety area where progress has not been made in almost three decades!

Survey respondents were asked to cite the largest obstacles to addressing speed. Seventy-eight percent selected "public indifference to speeding," while 61 percent selected "public perception that speed enforcement is just a revenue generator." Another 43 percent of respondents cited "lack of federal funding for enforcement."

A major challenge to the enforcement community is a reduction in state and local law enforcement personnel available to conduct speeding and aggressive driving enforcement efforts. Overall decreases in enforcement efforts can be challenging. Even while Idaho gets better at using crash data to determine locations most in need of speed reduction, the law enforcement community may not be available to target the dangerous areas. The staffing decreases are attributed to budget cuts, military deployments and the existence of other overtime shift assignments that are more desirable than speed enforcement.

The Idaho Office of Highway Safety remains committed to eliminate death and serious injury associated with speeding. Together we can make that difference as we move *Toward Zero Deaths*.

Seat Belt Use in 2011 – Overall Results

NHTSA Traffic Safety Facts Research Notes (DOT HS 811544)

Seat belt use in 2011 was estimated at 84 percent, statistically unchanged from 85 percent in 2010. This result is from the National Occupant Protection Use Survey (NOPUS), which is the only survey that provides nationwide probability-based observed data on seat belt use in the United States. The NOPUS is conducted annually by the National Center for Statistics and Analysis of the National Highway Traffic Safety Administration (NHTSA).

Seat belt use has show an increasing trend since 1994, accompanied by a steady decline in the percentage of unrestrained passenger vehicle (PV) occupant fatalities during daytime. The 2011 survey also found the following: click for the complete report.

Young passengers less likely to speak up about distracted driving; social icon design challenge offers an opportunity

Last week, I met a group of elementary school students in Minnesota, and I had a very clear safety message for them: "If you're riding in a car and the driver is texting or talking on the phone while driving, you tell them I said it's not safe."

And when I asked them if they would do that, if they would carry that important safety message home with them, they all nodded their heads enthusiastically and shouted, "Yes!"

That willingness to speak up is all the more important because, today, the National Highway Traffic Safety Administration released <u>new findings</u> that indicate older kids--teens--are the least likely passengers to say something to their driver if he or she is texting or talking on a cell phone behind the wheel.

At the same time, we know that drivers in their teens report the highest level of phone involvement in crashes and near-crashes. And we know that young drivers are nearly three times more likely to be involved in sending or receiving a text at the time of an incident than drivers 25 and older. Impaired Teenage Drivers

Recent data from the Substance Abuse and Mental Health Services Administration (SAMHSA) shows 26 percent of all teen drinkers (ages 12-17) get their alcohol from a parent or family member. Research shows this influence of parents in three out of four kids saying their parents are the leading influence on their decisions about drinking, and emphasizes the important role of parents in deterring underage drinking. <u>Ford Driving Skills for Life Trains Teen Drivers to Avoid Tragedy during Impending Prom and</u> **Graduation Season**

As prom and graduation season approaches, <u>Ford Driving Skills for Life (DSFL)</u> is reaching out with programs designed to address the increase in life-endangering risks that teen drivers face on the road. "This a time of year when many teens request, and parents provide, expanded driving privileges," said Jim Graham, manager, Ford Driving Skills for

Life. "Unfortunately, safety can take a back seat to the excitement associated with the many celebrations around prom and graduation."

According to the National Highway Traffic Safety Administration, traffic crashes are the leading cause of death among ages 15 to 20. The Governors Highway Safety Association (GHSA) reported a slight upward trend in teen traffic fatalities during the first six months of 2011, which is the most recent data available. Teen drivers, mile to mile, are in three times as many fatal crashes as other drivers, claiming the lives of nearly 3,000 teens each year. The under-20 age group also has the highest proportion of distracted drivers involved in fatal crashes.

"Driving is a privilege, not a right, and parents need to set certain limits to ensure their teens stay safe," added <u>Barbara Harsha</u>, GHSA executive director. "We recommend that parents talk with their teen drivers and together establish rules, including limits for the number of passengers, nighttime driving limits and a commitment not to text and drive. Every state has graduated license requirements and it is critical, especially during this season, that teens and parents are aware of and committed to follow these provisions."

Youthful Drivers

"Thirty percent of teens involved in serious car crashes suffer head injuries, including concussion, skull fractures and traumatic brain injuries (TBI), new research from medical and insurance experts says. While the report by The Children's Hospital of Philadelphia (CHOP) and State Farm highlights a decline in teen driver-related fatalities over the past six years, researchers said crashes remain the leading cause of death for teens and kill nearly five times as many 15- to 19-year-olds as cancer or poisoning."
