The attached list includes 42 new projects to the STIP. All projects included in this request went out for a 30-day public comment from July 1 – July 31, 2022 as part of the FY23-29 ITIP Draft Program process. These were each included in the FY 2023 – 2029 Recommended Program approved by the Idaho Transportation Board at their September 22, 2022 meeting. These projects are new due to being added in FY 2029 and have preliminary engineering, right of way, or construction costs scheduled in FY 2023. These development costs are needed in FY 2023 so the projects can be started as soon as possible, so they were added as opposed to advancing existing STIP projects forward. These projects are all outside the MPO areas. Projects in the MPO areas will be submitted under separate cover.
