RE: 2023 STIP Amendment #H12

Dear Mr. Stokes:

This approval amends the 2023 STIP to revise or add 4 projects, as requested in the attached ITD December 14, 2023, letter. This approval is based on the following:

- The changes to the program are not intermodal in nature and will not affect the State's conformity process and, therefore, FHWA has sole approval authority
- ITD certifies they have the mechanisms in place to ensure compliance with new rules required by the Bipartisan Infrastructure Law
- Our understanding that funds for KN 10005 cost increases are from the FRA Railroad Crossing Elimination grant program, funds for KN 19338 cost increases are from available funds due to deobligation/cost reductions from other projects, funds for KN 24089 project addition is from cost savings from KN 20710 and funds for KN 24385 project addition are from available funds due to de-obligations from KN 13998; therefore, the state maintains fiscal constraint
- ITD continues to demonstrate progress toward addressing the corrective actions noted in the 2023 Federal Finding
- This action does not serve as an eligibility determination of approval of Federal participation as some programs may have additional program requirements

In consideration of the above, ITD's 2023 STIP Amendment #H12 is approved, as requested.

SUBJECT: FY 2023 - 2029 STIP AMENDMENT - December 14, 2023 # H12

Dear Mr. Hartman:

The attached list consists of 4 projects, including additions, advancements, and increases. The construction costs on **KN** 10005 are being advanced to FY24 and increased, with funding offset from the FRA Railroad Crossing Elimination program grant. The construction on KN 19338 is being increased to match the detailed estimate for award with offsetting funds provided from the Statewide Balance. KN 24089 is being added and design advanced to FY24, with offsetting funds provided from KN 20710. **KN** 24385 is being added with unexpended funds in closeout that have been deobligated from KN 13998. These actions maintain fiscal constraint of the STIP. Furthermore, these projects have preliminary engineering, right of way, or construction costs scheduled in FY24; These development costs are needed in FY24 so the projects can be started as soon as possible, so they were added as opposed to advancing existing STIP projects forward.

The projects in this Amendment were included in the 12/1/23 - 12/10/23 public comment period, with no comments being received to share with IT Board members for consideration.

The Metropolitan Planning Organizations updated their individual Transportation Improvement Programs as follows: Kootenai Metropolitan Planning Organization - 12/13/2023.

The Department requests that these projects be amended to the FY 2023 - 2029 STIP so that funds may be obligated as planned.

No further public involvement or air quality conformity analysis is required. The Idaho Transportation Department certifies that the above actions meet all applicable requirements as described in 23 CFR 450.218 of *Planning Assistance and Standards*. The STIP continues to be consistent with the Idaho Transportation Department's 2040 Long-Range Transportation Plan as approved by the Idaho Transportation Board in 2019.
