- ITD certifies that cost savings from other projects provides the funding needed to maintain fiscal constraint,

- This action does not serve as an eligibility determination of approval of Federal participation as some programs may have additional program requirements.

Dear Mr. Hartman:

The attached list consists of four projects, requesting addition to the STIP. KN 24953 and 24954 are being added in accordance with the recommended list of projects submitted by LHTAC in the most recent TAP application approved by the IT Board. KN 24951 and 24952 are being added to satisfy long-term monitoring requirements from the construction of KN 11244 and 18933. The new projects will transfer funds from existing projects, maintaining fiscal constraint of the STIP. Furthermore, these projects have preliminary engineering, right of way, or construction costs scheduled in FY24; These development costs are needed in FY24 so the projects can be started as soon as possible, so they were added as opposed to advancing existing STIP projects forward.

The projects in this Amendment were included in the 4/8/24 - 4/17/24 public comment period, with no comments being received to share with IT Board members for consideration.

The Department requests that these projects be amended to the FY 2024 - 2030 STIP so that funds may be obligated as planned.

No further public involvement or air quality conformity analysis is required. The Idaho Transportation Department certifies that the above actions meet all applicable requirements as described in 23 CFR 450.218 of Planning Assistance and Standards. The STIP continues to be consistent with the Idaho Transportation Department's 2040 Long-Range Transportation Plan as approved by the Idaho Transportation Board in 2019.
