The Idaho Community Development Block Grant (CDBG) Program helps Idaho cities and counties develop needed public infrastructure improvements ... and also provides statewide contracting opportunities.

The Idaho Community Development Block Grant (CDBG) Program uses funds received annually from the U.S. Department of Housing and Urban Development for targeted infrastructure improvements. Eligible projects include those that benefit low and moderate-income persons, help prevent or eliminate slum and blight conditions, or solve catastrophic health and safety threats in local areas

The Idaho Department of Commerce, which administers the ICDBG Program, has announced the following 2016 competitive grantees.

### SBA 504 Refinance Program Made Permanent

Measure Designed to Help Small Businesses Grow and Create Jobs.

Eligible small business owners now have more options to refinance eligible fixed assets and business expenses through the Small Business Administration (SBA) 504 Refinance Program.

SBA Administrator Maria Contreras-Sweet made the program permanent through an Interim Final Rule in The Federal Register released May 26, 2016. This change will help small business owners ease their financial burdens and create incentives for potential expansion and further job creation.

The Section 3 (referring to a part of the Housing and Urban Development Act of 1968) **Business Registry** is a listing of firms that have self-certified that they meet one of the regulatory definitions of a Section 3 business and are included in a searchable online database that can be used by agencies that receive HUD funds, developers, contractors, and others to facilitate the award of certain HUD-funded contracts. (REFINANCE, Continued from page 4) In making the announcement, Contreras -Sweet said: "As both a former small business owner and a banker, I know firsthand that access to capital is the single most important factor in the survival and growth of a small business. The 504 loan program with its long term fixed-rate can help refinance debt from adjustable rate loans with significant savings to borrowers. Paying off existing loans with a new loan at a lower cost can help increase cash flow, which can be especially helpful in a resurgent economy. That's why I'm so proud to announce this Final Rule making 504 Refi permanent."

As outlined in the Interim Final Rule announcement, SBA will begin accepting applications from small business owners effective June 24, 2016.

Also, concurrent with the announcement, a public comment period will begin for the public to make recommendations that SBA will review for further program enhancements in the future. The public comment period will end July 25, 2016.

"For some time now, we've been making the case for the 504 Refinance Program with lawmakers, and now small businesses will have access to \$7.5 billion under this program. Congress heard the combined voices of small business, lenders and SBA, and made the 504 Refinance Program permanent — a measure that I'm sure will prove essential in helping small business expand and strengthen the nation's economy," Contreras-Sweet said.

On December 18, 2015, Congress passed the Consolidated Appropriations Act of 2016, which made the 504 Debt Refinancing Program a permanent part

(REFINANCE, Continued from page 5) of the 504 Loan Program. The 504 Refinance Program was originally a temporary measure under the Small Business Jobs Act of 2010. This temporary debt refinance program expired on September 27, 2012.

SBA is authorized to approve up to \$7.5 billion for the regular 504 Loan Program and \$7.5 billion in lending authority under the 504 Debt Refinancing Program, which brings the total 504 lending combined authorization to \$15 billion.

The 504 Debt Refinancing Program is authorized to operate only in fiscal years during which the subsidy costs to the government are zero.



(2016 SBA AWARD, Continued from page 6) ing; they were among the first roasters to support the Fair Trade movement to gain better wages for growers.

From literal beginnings in McDonnell's garage, Equator now has 90 employees and 350 wholesale customers including the renowned French Laundry restaurant, cafes at LinkedIn, micro-kitchens at Google and retail stores in Northern California.

The first award runner-up was Angela O'Byrne, President of **Perez, APC**, headquartered in New Orleans. Perez, APC has provided clients with design and construction services for more than 75 years.

O'Byrne acquired 100% ownership of the firm in 2000. With a staff of more than 50, she has grown the multidiscipline organization to 15 branch locations, including those along the East, West, and Gulf Coasts, the Midwest, and Afghanistan — despite losing 23 of 25 contracts as a result of Hurricane Katrina in 2005.

O'Byrne is also a passionate advocate for women in architecture and construction, and is involved in countless professional and nonprofit organizations dedicated to their industry advancement.

Second runner-up was Raymond Jardine Jr., Chairman/CEO of Native Hawaiian Veterans, LLC (NVH) in Honolulu. Jardine started NHV in 2005 with just three employees and first-year revenue of about \$64,000. In 11 years of operation, NHV has reached impressive heights in terms of expansion, revenues and jobs created.

By 2015, the company had already expanded his lines of business to all 50 states and territories, 20 countries, more than 200 employees and over \$30 million in gross revenue.

Jardine is a strong advocate of small businesses and has a proven history of

volunteer efforts to advance the small business community. He also contributes both time and money to many organizations such as the Kina'ole Foundation, the Native Hawaiian Organizations Association, the Native Hawaiian Chamber of Commerce and many others.

Third Runner-up was David Dafoe, Founder and Chief Operations Officer of Flavorman and Distilled Spirts Epicenter of Louisville, Kentucky.

Dafoe struck out on his own after a successful career with a local beverage company, where he worked to develop well-known drink mixes and cocktails. He formed Pro-Liquitech International in 1992, which later became Flavorman, an international customer beverage production company.

Dafoe started the company with one customer and no employees, but that quickly changed as the company rapidly grew. He currently has 30 full-time and four part-time employees.
