#### Exposure to harmful substances or environments

- Injury rate: 31.9 per 10,000 full-time workers
- Before the pandemic the 6th ranked. Increased to #1 because of COVID-19 cases
- Industry most at risk: health care and social assistance
- Typical days lost: 13
- Most frequent case type:
   Other diseases due to viruses, not elsewhere classified

#### Overexertion, bodily reaction

- Injury rate: 26.2 per 10,000 full-time workers
- Age group most at risk: 45 to 64
- Industry most at risk: transportation and warehousing
- Typical days lost: 14
- Most frequent part of body hurt: back

#3

#### Falls, slips, trips

- Injury rate: 22.6 per 10,000 full-time workers
- Age group most at risk: 55 and over
- Industry most at risk: transportation and warehousing and agriculture
- Typical days lost: 14
- Most frequent type of injury: sprains, strains, tears

#### Rural Transportation Assistance Program (RTAP)

The Idaho Transportation Department Public Transportation Office (ITD-PT) is responsible for administering Idaho's Rural Transportation Assistance Program (RTAP) with funding provided by the Federal Transit Administration (FTA). ITD-PT is committed to fostering a safe, mobility focused public transportation program throughout Idaho that promotes economic opportunity and growth for all of Idaho. ITD-PT budgets the 5311(b) RTAP funds on an annual basis and will offer scholarship opportunities until such funds are exhausted.

#### Individual Scholarship Eligibility

- Up to \$5,000 per person per training
- Can be used for courses, workshops, seminars, materials, driver training(s) and conferences with subject matter applicable to rural and specialized transportation, and appropriate to the level of expertise of the person(s) attending.
- Maximum of two (2) individuals per training, workshop or conferences. (ITD-PT may allow more than 2 for in-state events.)
- Maximum of three (3) training, workshop, or conference scholarships per individual per calendar year
- ITD Hosted trainings do not apply towards the maximums.
- Webinars, online conferences, and online trainings do not apply towards the maximums.



### In-House Scholarship Eligibility

- Eligible Expenses:
  - Course Costs
  - Material Costs
  - Trainer Fees




#### Reimbursements

- Submit before the deadline in your scholarship award email
- Submit the Individual Expense Form reflecting actual expenses.
- Attach required receipts for your expenses, as identified in the Idaho RTAP Scholarship Guidelines.
  - Meal reimbursements are made by per diem rates and do not require receipts.
- Submit a Summary Report on the training you received and rate the training as to whether you would recommend others to attend.


